Also, if a student or staff member would like to continue wearing a face covering, it will be allowed.

Dr. Slaton stated at this time, the CDC (Federal Government) is mandating that anyone riding on public transportation (school bus) must wear a mask. This is an ongoing debate at this time and Dr. Slaton will follow closely and notify everyone if it changes.
