**Board Work Session - Immediately Following Regular Meeting**

I. Call to Order

Mr. Mays called the Work Session to order at 5:39 p.m. with all members present along with Dr. Slaton, Mr. Brewster, and many of the administrators and directors.

II. [Discussion of Building and District Projects](#)

Dr. Slaton provided a slideshow created by administrators outlining facility needs throughout the district. Administrators were in attendance to prioritize projects and answer questions. A list of projects identified as priorities is listed below with the full list available in the above link.

**Johnson Elementary School**

- Playground equipment (in partnership with the PTO)
- Enclose Art & Music classroom - gym/removal of bleachers
- Paint gym doors and blue border around main hallway
- Replace kindergarten classroom floors
- Repair leaking HVAC units in kindergarten classrooms

### **Lexington Elementary School**

- Renovate office (carpet, paint, etc.)
- K-3 hallway restroom renovations
- Replace carpet to tile in remaining classrooms
- Curtain in gym and replace the wall

Mr. South noted that \$5,800 from the Good Faith Preschool was donated to the LES PTO and they hope to use those funds towards some new playground equipment.

### **Scottsburg Elementary School**

- New radios/access control (PreK entry/2nd classroom)
- Update restrooms in basement & enhance PreK entry
- Repair, paint & new stalls for 5th grade restrooms

### **Vienna-Finley Elementary School**

- Intercom system at front entrance for security
- Additional/updated security cameras
- New radios for safety (already purchased, received & distributed)
- Redesign area for SRO in front lobby

### **Scottsburg Middle School**

- Cafeteria & Great Room Lights (27 LED)
- Bottle filling water fountain by cafe and PE hallway
- Replacement sections of markerboards
- Restroom Hand Dryers (8)

### **SMS Refinance Bond (\$373,500)**

(these funds must be used at SMS or in the Central Office building and are required to be used relatively soon to avoid drawing interest)

- SMS carpet replacement (carpet tiles) - \$63,000
- Track resurfacing
- Repair tennis court cracks
- Window replacement (40 windows) and security film
- New guttering for old cafegymatorium
- Ceiling renovations for old cafegymatorium
- New floor for old cafegymatorium

### **Scottsburg High School**

- New digital sign
- McClain Hall bleachers (athletics and SHS to share cost)
- Kitchen water heater
- Storage Unit
- Paint SHS hallways
- Remodel athletic locker room
- Update teacher desks & main building furniture
- Remodel Guidance Department (redesign conference rooms/offices)

### **Athletic Department**

- McClain Hall bleacher replacement
- Soccer lights
- Soccer/track concession/press box
- Fence sections between track and band field
- Irrigation of football practice/band field

Mr. Lowry also noted that more parking around Meyer Gym would be necessary in order to ever host basketball sectionals.

Mrs. Craig made a motion to allow Dr. Slaton to begin the bond process and for the administrators to begin the process of addressing the priority items by getting quotes, etc. Mrs. Soloe seconded and motion carried 5-0.

Mr. Moore complimented the administrators on doing such a great job presenting their buildings' needs. Dr. Slaton introduced Mr. Mike Stricklin, a former school superintendent who was in attendance representing Core Construction, stating that he just wanted to hear what was going on in the district. Dr. Slaton also thanked Mr. Guy Townsend for donations made for the Cox family.
