## 4. Elementary Grade Level Capacity and Transfer Guidelines

There was much discussion regarding the transfer guidelines with different scenarios that schools could face. The board wants to make sure that every building is following the same guidelines to keep it fair as possible for parents. It was understood that there will be many special situations to take into consideration. Transfer requests will be reviewed by the building principal and the Superintendent or other designee. The board asked for some of the verbiage to be reworded and Dr. Slaton will see to that.

A PreK cost structure must be established prior to registration for the 2023-24 school year. Mr. Brewster shared how the PreK program has grown and is continuing to grow with having up to 5 classrooms in the ELA building next school year. Next school year, each elementary will have a full day class for four year olds. Other 3 to 4 year olds will be placed between LES or ELA.
